#### Student Readiness for Remote Instruction

### Provide a brief summary of your assessment of the readiness of your students to participate in remote courses/learning activities

- > Technology access:
- ➤ The College of Education has been working smoothly with student centered online activities for courses. Any student who had a financial need for a laptop this spring 2020 and summer 2020 semester was granted one through the FAMU Cares funding resource. Additionally, students who needed laptops with a lockdown browser such as Respondus was provided one through the library and Dean Watkins.
- ➤ The College of Education will have two open labs we can schedule for individual students or groups smaller than 10. These labs are GEC A209 and GEC, the Candidate Empowerment Center lab will be open by appointment only and two students are permitted with one employee.
- ➤ The College of Education placed an order and received 80 new desktop computers for our students. However, due to COVID-19, the entirety of technology can not be accessed at the same point and time.


### **Academic Support Services**
